REQUEST UNDER THE ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004 (EIRs)

Thank you for your request dated 27 September 2023 under the Environmental Information (Scotland) Regulations 2004 (EIRs).

Your request

You asked for:

• 'Any correspondence which includes or is directly to or from the Scottish Government's Minister for Energy and the Environment, Gillian Martin, both in her role as minister and before she became minister, which mentions the Peterhead CCGT power station development by SSE, from 01 January 2022 up to present?'

Response to your request

As the information you have requested is 'environmental information' for the purposes of the Environmental Information (Scotland) Regulations 2004 (EIRs), we are required to deal with your request under those Regulations. We are applying the exception at section 39(2) of the Freedom of Information (Scotland) Act 2002 (FOISA), so that we do not also have to deal with your request under FOISA.

This exception is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exception. We have found that, on balance, the public interest lies in favour of upholding the exception, because there is no







public interest in dealing with the same request under two different regimes. This is essentially a technical point and has no material effect on the outcome of your request.

I have enclosed a copy of the information you requested below in **Annex B**.

On reviewing material within scope of your request, exceptions have been applied in line with EIRs. The exceptions and relevant public interest tests can be found in **Annex A**.

Your right to request a review

If you are unhappy with this response to your EIR request, you may ask us to carry out an internal review of the response, by emailing Director of Energy and Climate Change, Kersti Berge at Kersti.Berge@gov.scot.

Your review request should explain why you are dissatisfied with this response, and should be made within 40 working days from the date when you received this letter. We will complete the review in accordance with the EIRs as soon as possible, and not later than 20 working days from the day following the date we receive your review request. If you are not satisfied with the result of the review, you then have the right to appeal to the Scottish Information Commissioner. - Some information has been withheld under regulation 10(4)(e) (internal communication). This exception is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exception.

We have found that, on balance, the public interest lies in favour of upholding the exception. We recognise that there is some public interest in releasing the information as part of an open, transparent and accountable government. However, this is outweighed by the greater public interest in allowing Scottish Government officials and ministers a private space to share free and frank views for the purpose of deliberation of any given policy.

• Some information has been withheld under regulation 10(5)(f) (Third Party Interests). This exception is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exception.

We have found that, on balance, the public interest lies in favour of upholding the exception. We recognise that there is some public interest in releasing the information as part of an open, transparent and accountable government. However, this is outweighed by the greater public interest in allowing external organisations the ability to engage with the Scottish Government with the strict understanding that their correspondence is held in confidence unless otherwise agreed.

 Additionally, information has been redacted from the documents disclosed under Regulation 11 – Personal Data, as it contains personal information and disclosing it would contravene the data protection principles in Article 5(1) of the General Data Protection Regulations (GDPR) and in Section 34(1) of the Data Protection Act 2018.

This exception is not subject to the 'public interest test'.

FM visit proposal – SSE Peterhead Power Station, 18 July 2023

Opportunity for the First Minister to tour the gas-powered Peterhead Power Station, which is awaiting green light from the UK Government on whether the ACORN carbon capture and storage (CCS) decarbonisation project can proceed.

As Scotland's biggest carbon emitter, Peterhead Power Station is the main emitter underpinning the ACORN project's ambition to transport carbon emissions for storage under the North Sea. It is critical to Scotland's national infrastructure as it supports energy supply in times when renewable sources (eg wind) are unable to maintain supply due to weather conditions. Greenlight on ACORN would enable it to continue to support energy supply as well as local employment in the energy sector.







FM would have the option to tour the power station during a shutdown period of summer maintenance, visiting the turbine hall to meet some of the dozen or so apprentices working at the site whose future careers rely on the Scottish Cluster of CCS projects progressing as part of making the power station compatible with net zero targets as part of a just transition.

SSE can also offer a presentation in the site library providing background on the existing site and outlining future plans for CCS on its site and broader benefits, which include the opportunity to turn Scotland into a CO2 input hub to support the net zero ambitions not just of Scotland but of the rest of the UK.

First Minister would then have an opportunity to undertake pooled media bids in the power station.

- o Central Belt The Grangemouth Project, Fife Hydrogen Hub
- In October 2021, UKG announced the Scottish Cluster (led by the Acorn Project at St Fergus) was unsuccessful in the Track-1 competition, however it was confirmed as a Track-1 "reserve".
- In March 2023 Budget, the UK Government announced £20 billion funding for CCUS projects (Track 1 projects in East and North West England, and North Wales), however none of this money was allocated to Scotland.
- Also in March 2023, the UKG published "Powering Up Britain" which also confirmed the Track 2 sequencing process to establish 2 further clusters by 2030, the UK government considers Acorn and Viking T&S systems as "best placed" to meet Track 2 eligibility (subject to due diligence and value for money assessments).
- The UK Government, whilst confirming that Acorn meets the Track 2 criteria, have, inexplicably decided to open up the Track 2 process by inviting other clusters to submit an expression of interest (EOI). Should any EOI be received by the end of April, that will necessitate a selection and assessment stage (competitive procurement). The expectation is that other clusters will submit an EOI.

Background

 UKG allocated over £30 million in development funding to the Scottish Cluster in 2021. This is not for delivery of Track 1 or Track 2 of the DESNZ Cluster Sequencing Programme. The significant industry and investor uncertainty around a lack of funding relates to there still being no confirmation of timing of and funding for the deployment of Acorn and the Scottish Cluster as part of the delayed Cluster Sequencing Programme.

Detail of Funding

- That funding was provided for the Scotland's Net Zero Infrastructure (SNZI)
 Programme as part of a £171 million funding package announced on 17 March 2021 under Innovate UK's Industrial Strategy Challenge Fund (ISCF). This funding forms part of the Industrial Decarbonisation Challenge.
 - SNZI brings together Pale Blue Dot, SSE Thermal, National Grid, Petrofac, LNG9/GB-Tron, Centre for Energy Policy at the University of Strathclyde, and NECCUS.
 - SNZI will be employed to develop net zero infrastructure for both Hydrogen and CCUS, including:
 - Detailed engineering for the Acorn CCS and Hydrogen projects to enable a final investment decision, and allow carbon abatement from the mid-2020s:
 - Developing a new CCS-equipped power station at Peterhead, capable of producing large volumes of predictable Net Zero 'base-load' power;
 - Options for the re-use of onshore pipelines to transport CO2 from large industrial clusters across the Central Belt and East Coast of Scotland to secure stores in the North Sea;
 - Engineering design for carbon capture on a new proposed gas-fired power station in Grangemouth; and
 - Development of a 'fabrication ready' design of CO2 tanker ship which can service the needs of coastal CO2 emitters around the UK for delivery to Scottish CO2 stores.
 - While the Scottish Cluster received £31 million in funding, it is not the only cluster that received funding as part of the Industrial Decarbonisation Challenge:
 - HvNet North West received £33 million in funding.
 - Members of the East Coast Cluster (i.e., Net Zero Teeside and Zero Carbon Humber) received around £50 million in funding.
 - The Northern Endurance Partnership, which will enable the East Coast Cluster, received £24 million in funding.
 - Humber Zero, focused on the Immingham Industrial Cluster, received £13 million in funding.
 - o The South Wales Industrial Cluster received £20 million in funding.
