REQUEST UNDER THE ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004 (EIRs)

Thank you for your request of 5 June 2024 under the Environmental Information (Scotland) Regulations 2004 (EIRs).

Your request

You asked for:

"On 3rd May 2024, Mairi McAllan Cabinet Secretary wrote to Ben Christman at the Environmental rights Centre for Scotland (your reference: Request for SEPA direction - incineration overcapacity (05.0623)), and stated:

An additional capacity analysis was commissioned, through Zero Waste Scotland, as part of work to consider delivery of the ban on landfilling biodegradable municipal wastes. The outputs and recommendations of this work are currently under consideration by the Scottish Government.

Please send me (1) a copy of this report, (2) the terms of reference for it and (3) any correspondence held relating to the report."

Response to your request

As the information you have requested is 'environmental information' for the Purposes of the Environmental Information (Scotland) Regulations 2004 (EIRs), we are required to deal with your request under those Regulations. We are applying the exemption at section 39(2) of the Freedom of Information (Scotland) Act 2002 (FOISA), so that we do not also have to deal with your request under FOISA.







This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption, because there is no public interest in dealing with the same request under two different regimes. This is essentially a technical point and has no material effect on the outcome of your request.

Questions 1 & 2

An exception under regulation 10(4)(d) of the EIRs (material in the course of completion/unfinished information) applies to the information you have requested, namely for copies of the ban on Landfilling Biodegradable Municipal Waste (LBMW) report and associated terms of reference respectively because these are currently incomplete and are under final review by Zero Waste Scotland in advance of publication to ensure that no commercial and/or sensitive information is disclosed.

It may help if I explain that the LBMW report and associated terms of reference were commissioned by Zero Waste Scotland (ZWS). Whilst the Scottish Government have been provided with draft copies of these documents for consideration, as noted above these are currently incomplete and may provide an inaccurate representation of the reports final conclusions.

The Scottish Government has provided further information on the indicative timescale for ZWS to publish the finalised materials as part of our response to Parliamentary Question S6W-27871 with publication intended to follow the UK General Election of 4 July 2024.

This exception is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exception. We have found that, on balance, the public interest lies in favour of upholding the exception. We recognise that there is some public interest in release as part of open, transparent and accountable government. However, this is outweighed by the public interest in ensuring that unfinished and/or incomplete information which is still being worked on is not disclosed when it might misinform the public or give a misleading impression of the Scottish Government's position on the matter to which the information relates.

Question 3

I have included copies of the information you have requested in Annex B.

On reviewing materials within the scope of your request, exceptions have been applied in line with the EIRs. The exceptions applied can be found in Annex A.

I would note that the document of 1 April 2024 included in Annex B makes reference to a final report provided by SLR Consulting, however, this was a draft version of the LBMW report provided to the Scottish Government for consideration as noted in my response to Questions 1 & 2 above and is therefore an incomplete version.

Your right to request a review

If you are unhappy with this response to your EIR request, you may ask us to carry out an internal review of the response, by emailing David Signorini, Director of Environment and Forestry at Director.Enfor@gov.scot.







Your review request should explain why you are dissatisfied with this response, and should be made within 40 working days from the date when you received this letter. We will complete the review and tell you the result, within 20 working days from the date when we receive your review request.

If you are not satisfied with the result of the review, you then have the right to appeal to the Scottish Information Commissioner. More detailed information on your appeal rights is available on the Commissioner's website here.

ANNEX A

Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exception. We have found that, on balance, the public interest lies in favour of upholding the exception. We recognise that there is some public interest in releasing the information as part of an open, transparent and accountable government. However, disclosure of this particular information would, or would be likely to, prejudice substantially the confidentiality of commercial information provided by private 3rd party companies and cause substantial harm to their commercial interests.

Additionally, a small amount of information has been withheld under Regulation 11(2) – Personal Data as it contains personal information and disclosing it would contravene the data protection principles in Article 5(1) of the General Data Protection Regulations (GDPR) and in Section 34(1) of the Data Protection Act 2018. This exception is not subject to the 'public interest test'.
