



HOWEVER, POLITICIANS IN THE GLOBAL NORTH CONSISTENTLY DOWNPLAY THEIR POWER TO EVOKE CHANGE AND ARE FAILING TO TAKE THE FIRST STEP TOWARDS RESOURCE JUSTICE DESPITE THE URGENT NEED TO ACT NOW.

Examples of resource justice policies

For all governments

- Introduce standards to protect people and national resources from corporate exploitation
- Change how societal improvement is measured from focus on economic growth and GDP to measures of wellbeing
- Develop comprehensive domestic waste management programmes focused on access to high quality reuse and recycling services for all citizens and minimising waste exports
- Engage in international efforts to develop internationally fair and sustainable supply chains

For governments in the global north

- Introduce mandatory standards to improve the fairness and sustainability of corporate supply chains internationally (sometimes known as due diligence standards),
- Develop sustainable procurement requirements and guidance for the public and private sectors
- Ban planned obsolescence
- Ensure citizens have extensive rights to repair the products they buy
- End food waste
- Require companies to pay for the waste their products create through Extended Producer Responsibility Schemes
- Create a shared and equitable space for global south and global north countries to develop internationally fair and sustainable supply chains together

For governments in the global south

- Introduce mandatory standards for corporations operating domestically, to protect citizens, especially indigenous people and local communities, from the effects of resource injustices
- Commit to urgently ending any overexploitation of national resources
- Make plans to adapt resource use as the effects of climate change increase
- Advocate for loss and damage funds to be used to decarbonise their economies, to enable
 a just transition and for climate adaption
- Work with global north nations to improve resource justice on an international level
